Workshop

<u>1:15p.m.</u> -Representatives from the Roanoke Park Conservancy presented proposed plans for the shade structure and answer any questions of the Board.

On November 21, 2016, the Roanoke Park Conservancy (RPC) presented plans for a custom shade structure to be located at the new Karnes Playground to the Park's Development Review Committee.

The new playground has been very popular among children and parents and one priority that has been identified since it's opening in April 2016, is the lack of shade. Through a design competition with Roanoke Park neighbor, Hufft Projects, the design selected by the RPC was submitted by local artist and fabricator, Burgess Zbryk.

Resolution #30799 - Agreement with PeaceWorks Kansas City

On a motion by Commissioner Dillingham, duly seconded the Board approved the Agreement with PeaceWorks Kansas City and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: PeaceWorks Kansas City wishes to enter into a Facility Use with Concession Agreement for the use of Southmoreland Park, located at Emanuel Clever II Boulevard and Oak Street, to hold their annual UnPlaza Art Fair on September 23rd and 24th, 2017. The Parks and Recreation Department will be compensated in the amount of \$1,900.00 for this 2 day event; \$900 each day of sales (2) and \$100 each day of set-up (1).

The UnPlaza Art Fair is a fundraiser for PeaceWorks Kansas City, a non-profit peace group with a vision of "A healthy world of justice and peace without war and weapons". The art fair will consist of various vendors offering ceramics, woodworking, jewelry, glasswork, fiber art, sculpture, photos, paintings, and more. Normally held on the lawn of All Souls Unitarian Universalist Church, this annual event is looking to relocate in 2017, due to construction at the church this fall. Expected attendance is around 700 people per day and the art fair runs 10:00 am to 6:00 pm on Saturday and 10:00 am to 5:00 pm on Sunday. KCPD off-duty will be on hand for security in the park.

Resolution #30800 - Agreement with Penn Valley Park Conservancy for Plein Art Fest 2017

On a motion by Commissioner Mecklenburg, duly seconded the Board approved the Agreement with Penn Valley Park Conservancy and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: The Penn Valley Park Conservancy wishes to enter into a Facility Use with Concession Agreement for the use of Penn Valley Park, located at W. 28th Street and Wyandotte, and Union Cemetery, located at E. 28th Terrece, to hold the Penn Valley Park Plein Air Fest, May 5 through 13, 2017. The Parks and Recreation Department will be considered a partner in this event and proceeds from registrations and art sales will go towards the Conservancy's mission to restore, preserve and enhance historic Penn Valley Park as a vital urban green space.

The 2017 Plein Air Fest will attract artists from across the region to partake in a nine day paint-off, capturing Penn Valley Park en plein air while competing for prize money. Artists will have from 8 am, May 5th through 10:30 am, May 13th, to capture the park painting en plein air and submissions will be judged. Plein Air Fest will also feature three Quick Paints, a timed competition for artists to complete an entire painting within a specified amount of time. The Quick Paints will be held May 9th at Firefighters' Fountain, May 11th at Union Cemetery and May 13th at the Penn Valley Lake. After an invitation only awards and preview party in the evening of May 13, an exhibit of the artwork will be held at the Buttonwood Art Space until June 24, 2017.

Background: The Native Sons and Daughters of Greater Kansas City are among the oldest, most enduring historical societies in Kansas City and have unquestionably been a major force in preserving and promoting the region's history. They have worked to preserve sites and encourage recognition of local people and events, to secure documents and records of our community's past, and to enrich public knowledge of Kansas City's rich heritage.

The mission of the Native Sons and Daughters of Greater Kansas City is dedicated to the historic preservation of the unique heritage of the greater Kansas City metropolitan area through advocacy, education and restoration. Their mission compliments the mission of KC Parks mission of improving the quality of life, health and wellness of our community by providing socially equitable, community-driven programming and environmentally sound natural resource management.

The Native Sons and Daughters of Greater Kansas City have been working diligently to raise the funds necessary to build and maintain the monument. The KC Parks staff has been working with the Native Sons and Daughters Project team to find a suitable location for their monument that would be in mutual alignment with the objectives of both organizations. After working through several locations and layouts, a site was selected. The proposed monument will be located within Ilus W. Davis Park near the intersection of 10th Street and Oak Street. Both organizations will continue to work together to develop plans for a monument that will be a lasting tribute to both the Native Sons and Daughters of Greater Kansas City and the park within which it will reside.

Resolution #30802 - Agreement with Zona Rosa Development LLC

On a motion by Commissioner Mecklenburg, duly seconded the Board approved the agreement with Zona Rosa Development LLC for the use of Town Square on August 5, 2017 and authorized the Director for the Director or his designee to execute the amendment on behalf of the Board.

Background: License agreement with Zona Rosa Development LLC to utilize the Zona Rosa Town Square located at N. Dixon. The Platte County Sports Commission (PCSC), in partnership with Kansas City Parks and Recreation and Platte County Parks and Recreation will be holding its 3rd Youth Sports Festival. The term of the contract is a single day on August 5, 2017 from 8a.m. to 5p.m.

The purpose of the Youth Sports Festival is to provide families the opportunity to learn more about the available youth sports programs in the area, and provide them an opportunity to learn about new sports.

Zona Rosa will provide the following;

- (A) Storage of materials related to the Event;
- (B) Vendor displays and vendor sales for the Event;
- (C) Interactive sports demonstrations and/or activities, including sports mascots.

Resolution #30803 - Agreement with Missouri Department of Transportation for a Community Garden in Freeway Park

On a motion by Commissioner Cade, duly seconded the Board approved the Agreement with the Missouri Department of Transportation for a Community Garden in Freeway Park and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: Freeway Gardens is located at 14th and Indiana has been continuously leased from the Missouri Department of Transportation Commission (MoDOT) since 1970. This property was originally acquired by MoDOT for improvements along the I-70 corridor.

The present lease expires on March 31st 2017. The Missouri Department of Transportation Commission is willing to enter into a new lease for five years, which, is the maximum now permitted. The terms of the agreement have not changed other than the expiration dates being updated.

Freeway Gardens is approximately 2.27 acres in size and has been used as a community garden and playground. The amount of the lease is one dollar.

MoDOT is requesting that the parcel be named "Freeway Gardens" as it protects them in the event that they need the right-of-way back if I-70 is to be further improved. Federal funding could be difficult to obtain if the designation "Freeway Park" is used as the name.

RESOLUTION #30803

WHEREAS, approximately 2.27 acres were acquired by the Missouri Highway Commission for improvements along the I-70 Corridor, in the vicinity of 14th and Indiana; and

WHEREAS, in 1970 the Board authorized a lease agreement for ten years between the Missouri State Highway Commission and the Board of Parks and Recreation Commissioners of Kansas City, Missouri; and

WHEREAS, in 1981 the Board authorized a lease for an additional ten years; and

WHEREAS, in 1992 the Board authorized a lease for an additional ten years; and

WHEREAS, in 2002 the Board authorized a lease for an additional ten years; and

WHEREAS, in 2012 the Board authorized a lease for an additional five years: and

WHEREAS, Freeway Park has been developed as a community garden and neighborhood playground; and,

WHEREAS, MoDOT requests that the parcel be named "Freeway Gardens" as it protects them in the event that they need the right-of-way back if I-70 is to be improved.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF PARKS AND RECREATION COMMISSIONERS OF KANSAS CITY, MISSOURI THAT:

- 1. The Director of Parks and Recreation is authorized to execute the lease on behalf of the Board.

Resolution #30804 - Agreement with Brinshore Development LLC

On a motion by Commissioner Mecklenburg, duly seconded the Board approved Agreement with Brinshore Development, LLC for improvements to park property adjacent to Independence Plaza Park and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: The Board of Parks and Recreation Commissioners is being requested to enter into an agreement by and with the Brinshore Development, LLC for use of parkland adjacent to Independence Plaza Park. The area of land is separated from the park by a brick and stone wall. The purpose of this strip of land is to access the north side of the stone wall for maintenance and construction. This portion of Independence Plaza Park is located on the north side of Independence Boulevard at Park Ave. Independence Plaza Park, in its entirety, is approximately 1.73 acres in size and acquired in 1896.

This agreement defines both license and maintenance terms for the use of parkland adjacent to their property at 553 Brooklyn. Brinshore Development, LLC acquired their property at 553 Brooklyn and has been making improvements to the buildings and the surrounding property ever since. The improvements located on parkland included in this agreement are a driveway and green space area. The improvements located on parkland are for the benefit for the development owned by Brinshore Development, LLC and will server for access needed by KC Parks.

Brinshore Development, LLC will be responsible for compensating the Department \$362,865.00 for a thirty year term of this agreement via a onetime fee. The licensee has the option to make improvements to Independence Plaza Park for a sum of the value of agreement or a combination of improvements and payment. The list of improvements identified are a new playground and safety surface, modifications to the wall along the north side of Independence Blvd., and additional openings for pedestrian access and exercise stations. The licensee will be responsible for complying with all the terms set forth in the agreement such as maintaining a certificate of insurance for use of the area and keeping it in a clean and safe condition. The agreement has an initial term of thirty years with a renewal for up to 15 additional terms. Furthermore, the agreement defines the conditions by which modifications and cancellations may occur.

Resolution #30805 - Agreement with the Pilgrim Center

On a motion by Commissioner Cade, duly seconded the Board approved the Agreement with Pilgrim Center to design, construct, maintain and operate the Hyde Park Harbor Garden and Labyrinth and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: On August 11, 2016, the Pilgrim Chapel presented plans to the Park's Development Review Committee to design, construct, maintain and operate the Hyde Park Harbor Garden and Labyrinth is generally located in Hyde Park at E. 37th Street and Gillham Road.

The Pilgrim Center is a nonprofit organization focused on driving community involvement in urban Kansas City through arts programs, neighborhood initiatives, and public events. The proposed Hyde Park Harbor Garden and Labyrinth is meant to be a walkable meditative area and will feature plantings to support butterfly habitat, while also enhancing one of Kansas City's most treasured parks.

The cooperative agreement will allow the Pilgrim Center to construct the project on Park property. The Pilgrim Center shall be responsible for all volunteer labor, tools and materials necessary for the construction of the garden. Following completion of construction, the Pilgrim Center shall maintain the garden.

The initial term of agreement is for 5 years from the effective date, and may be renewed thereafter by mutual agreement of the parties.

Resolution #30806 - Agreement with D & D Custom - 2017 Citywide Playground Project

On a motion by Commissioner Dillingham, duly seconded the Board approved Bid Award to D & D Custom Construction for the base bid and Alternate 3 for a total contract price \$173,880.00, with a substantial completion date of October 1, 2017 and authorized the Director or his designee to execute the contract on behalf of the Board.

Background: Five bids were received and opened on March 1, 2017 for the 2017 Citywide Playgrounds project. This project generally includes the installation of play equipment and concrete trails.

D & D Custom Construction submitted the lowest and best base bid amount of \$158,840.00 for play equipment, safety surfacing and a concrete walking trail at Iser Park. The total contract amount being awarded for the base bid and Alternate 3 is \$173,880.00. Alternate 3 adds \$15,040 for concrete work at Tiffany Hills Park. Alternate 1, in the amount of \$37,850.00 was for a new playground installation at Frank Vaydik Park. Alternate 2, in the amount of \$47,500.00, were for a new playground installation at 9th and Van Brunt Athletic Fields. Alternates 1 and 2 were cost prohibitive and not included in the bid award.

The contractor has 150 calendar days to complete the work from notice to proceed.

The HRD goals for this project are 7% MBE and 7% WBE. D & D Custom Construction has proposed goals of 7% MBE and 7% WBE which has been reviewed and approved by HRD. Funds for the 2017 Citywide Playgrounds project are available in accounts 3090-708609-70174920 for Iser Park and 3090-708209-70174922 for Tiffany Hills Park.

Resolution #30807 - Bid Award to Gunter Construction - James A. Reed Bannister Park Project

On a motion by Commissioner Mecklenburg, duly seconded the Board approved the Bid Award to Gunter Construction for a base bid, alternates 1,2,4,5 and 6 for a total contract price of \$617,043.00, with a substantially completion date of November 1, 2017 and authorized the Director or his designee to execute the contract on behalf of the Board.

Background: Five bids were received and opened on March 15, 2017 for Bannister and James A Reed Park Improvements. This project generally includes the construction of playground and trail improvements at both parks.

Gunter Construction submitted the lowest and best base bid amount of \$426,978.00 for improvements to Bannister and James A Reed Parks. The total contract amount being awarded for the base bid and alternates one, two, four, five and six is \$617,043.00. Alternate one adds \$10,785.00 for gravel surface to 5' nature trail at James A Reed Park; Alternate two add \$59,710.00 for synthetic surfacing for existing play area at James A Reed Park; Alternate 4 adds \$27,715.00 for a 2-5 age appropriated component play piece at Bannister Park; Alternate 5 adds \$42,920.00 for synthetic grass on existing play area at Bannister Park; and Alternate 6 adds \$

48,935.00 for two fitness stations and surfacing around the equipment at Bannister Park. Alternate three, in the amount of \$179,575.00, was for the complete removal of the asphalt trail and installation of a concrete trail. This item was cost prohibitive and not included in the bid award.

The contractor has 180 calendar days to complete the work from notice to proceed and substantially completed by November 1, 2017.

The HRD goals for this project are 14% MBE and 11% WBE. Gunter Construction submitted a participation plan with 14% MBE and 11%WBE. HRD is reviewing the participation plan. Funds for Bannister and James A Reed Park Improvements Project are available in accounts 3090-708509-70164923 for Banister Park and 3090-708509-70164924 for James A Reed Park.

<u>Resolution #30808 - Amendment # with International Architects Atelier - Kansas City</u> <u>Museum Planning Process agreement</u>

On a motion by Commissioner Judy, duly seconded the Board approved Amendment # 4 with International Architects Atelier to extend the contract time to December 31, 2017 and authorized the Director or his designee to execute the amendment on behalf of the Board.

Background: On February 10, 2015, the Parks Board approved the design professional agreement with International Architects Atelier for Phase One, the Discovery Phase, of the Kansas City Museum Planning Process for \$249,914.00. International Architects Atelier and their project team investigated and documented the existing physical conditions of the museum complex (five buildings and grounds) and prepared the following: a conditions survey, utility needs and assessment report, site survey, geotechnical report, environment assessment report, exterior way-finding signage, and community outreach.

Amendment #1 of the contract provided for additional scope of work including the development of a Master Plan. It increased the contract amount by \$567,890.00 and extended the completion date to May 17, 2016. Amendment #2 of the contract solely extended the time of the contract with a completion date of December 31, 2016. Amendment #3 of the contract solely extended the time of the contract with a completion date of March 31, 2017.

Amendment #4 of the contract solely extends the time of the contract with a completion date of December 31, 2017.

The original MBE/WBE goals set by HRD were 11% and 6% respectively. International Architects Atelier met them and exceeded them for the original agreement at 15.8% and 3.7%. For Amendment #1, HRD approved International Architects Atelier's Request for Modification of the MBE/WBE goals of 7% and 5% respectively. 

The contract completion date will be extended to June 30, 2017.

Funding will be available under project numbers 70174927, 70400120, 70400135, 70171306 and in Fund Account numbers 203-707704, 203-707769 and 203-707708.

The MBE/WBE goals set by the Human Relations Department are 15% and 6% respectively. HRD approved the goals submitted by D & D Custom Construction of 15% and 6%. D & D Custom Construction is required to meet these goals by the end of the project.

Background

Blue Trail System has been an expanding system and extends along the Indian Creek and Blue River from Kansas to Minor Park. This includes a section of the trail under I -435 near the Blue River where the trail goes under the existing highway bridges. This property was originally acquired by MoDOT for improvements along the I-435 corridor. KC Parks entered into a trail-way license agreement with MoDOT for the trail construction under their bridges.

MoDOT is planning some capacity improvement to their bridges on I-435 over the Blue River that may affect the use of the Blue River Trail during construction. Their improvement may need to reroute, close, provide a protective barrier during construction, or any combination of these efforts.

MoDOT is using federal funds for their capacity improvement and requires the project to obtain 106 Environmental clearance for the project. When parkland is within a project area, a 4F release letter is required from the jurisdictional Parks Department. The land in this area is owned by Jackson County and KC Parks operates and maintains the trail so a 4F letter is required from both Park Departments.

Recommendation

Staff recommends Board approval of the 4F release letter for MoDOT to perform their I-435 capacity project at the Blue River, and requests authorization for the Director or his designee to execute the agreement on behalf of the Board.









BACKGROUND AND DESCRIPTION

The Board entered into an agreement with Safety Tree Service LLC on May 3, 2016 to provide tree maintenance Services. The contract addresses tree maintenance pruning and removals on public properties and right of ways, including citizen's 311 action center requests. This contract also required the contractor to provide storm response services in the amount of \$400,000.00

Amendment #1 will provide for tree maintenance services: tree pruning and removals on public properties and right of ways, including citizen's 311 action center requests at the same rates in the Parks Central Region amount of \$300,000.00, bringing the total contract amount to \$700,000.00.
