On a motion by Commissioner Judy, duly seconded the Board approved the Minutes from the meeting of March 28, 2017.

Resolution #30810 - Agreement with the Kansas City Rose Society

On a motion by Commissioner Mecklenburg, duly seconded the Board approved the Agreement with the American Rose Society and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: The American Rose Society wishes to enter into a Facility Use with Concession Agreement for the use of the Laura Conyers Smith Municipal Rose Garden, located in Loose Park, to hold the 7th Annual Wine and Roses on Thursday, September 21, 2017. This event will help the Kansas City Rose Society fund additional rosebushes, garden maintenance, and the continuation of free community programs and events throughout the year.

Wine and Roses hopes to bring about awareness to the Laura Conyers Smith Municipal Rose Garden, its relationship with the Kansas City Rose Society and to increase the society's membership. The event will feature music, wine and food. Wine and Roses will run from 5:00 pm to 7:00 pm and coordinators hope for 150 or more attendees.

The contractor will be responsible for providing the following items:

Resolution #30811 - Agreement with the Roanoke Park Conservancy- Karnes Playground

On a motion by Commissioner Mecklenburg, duly seconded the Board approved the Agreement with Roanoke Park Conservancy and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: On November 21, 2016, the Roanoke Park Conservancy (RPC) presented plans to the Development Review Committee to design, construct and maintain a custom shade structure to be located at the new Karnes Playground at Karnes Boulevard and Madison Avenue.

The new playground has been very popular among children and parents and one priority that has been identified since it's opening in April 2016, is the lack of shade. Through a design competition with Hufft Projects, the design selected by the RPC was submitted by local artist and fabricator, Burgess Zbryk.

The RPC shall be responsible for all volunteer labor, tools, and materials necessary for the construction of the shade structure. Following completion of construction, the RPC shall be responsible for the maintenance and repairs as needed.

The initial term of the agreement is for 5 years from the effective date, and may be renewed thereafter by mutual agreement of the parties.

<u>Resolution #30812 - Amendment #4 with Kansas City United Tennis, LLC - Plaza Tennis</u> <u>Center</u>

On a motion by Commissioner Cade duly seconded the Board approved Amendment #4 with Kansas City United Tennis LLC to manage the Plaza Tennis Center, from May 1, 2017 to April 30, 2018, to pay \$1,470.00 monthly for rent and \$30.00 per month and authorized the Director or his designee to execute the amendment on behalf of the Board.

Background: On May 15, 2014 the Parks and Recreation Department entered into a Professional Services Contract with Kansas City United Tennis to operate the Plaza Tennis Center. The Director was authorized to enter into an amendment to extend the term of this Contract and time of performance for this Contract for up to five years. This amendment #4 exercises the option to extend the existing contract for year four. The term of this amendment will begin on May 1, 2017 and end on April 30, 2018. Kansas City United Tennis will pay \$1,470.00 monthly for rent.

Kansas City United Tennis will retain all revenues and be responsible for all expenses. The KCMO Parks and Recreation Department will provide trash services for a fee of \$30.00/month during the months this service is required, along with approved maintenance of the building and structures. Kansas City United Tennis will maintain the landscaping of the exterior and interior grounds of the facility. Kansas City United Tennis will also assume responsibility for the telephone lines used at the facility.

Staff recommends Board approval of amendment #4 with Kansas City United Tennis LLC to manage the Plaza Tennis Center, from May 1, 2017 to April 30, 2018, to pay \$1,470.00 monthly for rent and \$30.00 per month for the months they require trash collection

<u>Resolution #30813 - Amendment #1 with STRATA Architecture & Preservation - 2016</u> Citywide Fountain & Monument Renovation

On a motion by Commissioner Dillingham, duly seconded the Board approved Amendment #1 with STRATA Architecture & Preservation in the amount of \$115,752, extended the contract completion date to October 1, 2017 and authorized the Director for the Director or his designee to execute the amendment on behalf of the Board.

Background: On September 12, 2016, the City entered into a contract with STRATA Architecture & Preservation, in the amount of \$102,205, to perform diagnostic services for the Spirit of Freedom Fountain and for the pergola on The Paseo. The scope included an assessment of the condition of each structure and site; a determination of what repairs or renovations are required; establishment of priorities for the repairs; and estimation of the cost of the repairs.

Amendment #1, in the amount of \$115,752.00, to prepare the construction documents, perform bidding and negotiation services, and manage construction administration for the renovation of the Spirit of Freedom Fountain, would bring the contract total to \$217,957.00. It would extend the contract completion date to October 1, 2017.

The Amendment #1 is funded by PIAC funds, in accounts #3090708093 and #3090708309. The Human Relations Department has approved the participation goals of 23% MBE and 13% WBE and the goals will be met or exceeded at the close-out of the project.

Resolution #30814 - Change Order #6 with D & D Construction - Citywide Parks & Right-of-Way Improvements

On a motion by Commissioner Mecklenburg, duly seconded the Board approved Change Order #6 with D & D Custom Construction, in the amount of \$105,905.00, extended the contract completion date to June 30, 2017 and authorized the Director or his designee to execute the agreement on behalf of the Board.

Background: On January 12, 2016 the Board approved a construction contract with D & D Custom Construction in the amount of \$401,292. The scope included parking lot improvements at the Bruce R. Watkins Cultural Center, stone wall repairs in Kessler Park, and track resurfacing and restriping at Center High School. A Notice to Proceed was issued on March 28, 2016 with a project completion date of June 26, 2016.

Change Orders #1, #2, #3, #4 and #5 in the amount of \$1,036,565.00 added additional scope and brought the contract total to \$1,437,857.00. It extended the completion date to March 30, 2017.

This Change Order #6, in the amount of \$148,765.00 includes repairs to stone walls at Case Park for \$40,800.00, Shawnee Mission & Ward Parkway for \$18,500.00, concrete sidewalk

repairs at Tiffany Springs & Skyview for \$3,100.00, Minor Park Clubhouse Paths Improvements for \$31,605.00, Sheila Kemper Dietrich wall repair for \$11,900.00, and Grove Pool sidewalk replacement for \$42,860.00 bringing the contract total to \$1,586,622.00. The contract completion date will be extended to June 30, 2017.

Funding will be available under project numbers 70174927, 70400120, 70400135, 70171306 and in Fund Account numbers 203-707704, 203-707769 and 203-707708.

The MBE/WBE goals set by the Human Relations Department are 15% and 6% respectively. HRD approved the goals submitted by D & D Custom Construction of 15% and 6%. D & D Custom Construction is required to meet these goals by the end of the project.

Resolution #30815 - Approval of the 4F Release Letter for MoDot - I-435 Capacity Project at the Blue River Trail

On a motion by Commissioner Dillingham, duly seconded the Board approved the 4F release letter for MoDOT to perform their I-435 capacity project at the Blue River and authorized the Director to sign the letter on behalf of the Board.

Background: Blue Trail System has been an expanding system and extends along the Indian Creek and Blue River from Kansas to Minor Park. This includes a section of the trail under I - 435 near the Blue River where the trail goes under the existing highway bridges. This property was originally acquired by MoDOT for improvements along the I-435 corridor. KC Parks entered into a trail-way license agreement with MoDOT for the trail construction under their bridges.

MoDOT is planning some capacity improvement to their bridges on I-435 over the Blue River that may affect the use of the Blue River Trail during construction. Their improvement may reroute, close, provide a protective barrier during construction, or any combination of these efforts.

MoDOT is using federal funds for their capacity improvement and requires the project to obtain 106 Environmental clearance for the project. When parkland is within a project area, a 4F release letter is required from the jurisdictional Parks Department. The land in this area is owned by Jackson County and KC Parks operates and maintains the trail so a 4F letter is required from both Park Departments.

Resolution #30816 - Amendment #1 with Safety Tree Service for Maintenance Services - Central Region

On a motion by Commissioner Mecklenburg, duly seconded the Board approved Amendment #1 with Safety Tree Service Company to add \$300,000.00, extend the contract time to May 3, 2018 and authorized the Director or his designee to execute the amendment on behalf of the Board.

Background: The Board entered into an agreement with Safety Tree Service LLC on May 3, 2016 to provide tree maintenance Services. The contract addresses tree maintenance pruning and removals on public properties and right of ways, including citizen's 311 action center requests.

This contract also required the contractor to provide storm response services in the amount of \$400,000.00

Amendment #1 will provide for tree maintenance services: tree pruning and removals on public properties and right of ways, including citizen's 311 action center requests at the same rates in the Parks Central Region amount of \$300,000.00, bringing the total contract amount to \$700,000.00. It is estimated that this contract will address approximately 1,000 trees in this Park Region. Funding in the amount of \$300,000.00 is available in account #3090-707771. Amendment #1 will also provide a one-year extension of the contract term to May 3, 2018

The Contractor's Utilization Plan meets MBE/WBE goals for this contract of 17% MBE and 0% WBE respectively and will apply to this amendment #1, and any future amendments, to this contract.

Resolution #30817 - Amendment #2 with Safety Tree Service for Maintenance Services - South Region

On a motion by Commissioner Mecklenburg, duly seconded the Board approved Amendment #2 with Safety Tree Service Company to add \$500,000, extended the contract time to May 3, 2018 and authorized the Director or his designee to execute the amendment on behalf of the Board.

Background: The Board entered into an agreement with Safety Tree Service LLC on May 3, 2016 to provide tree maintenance Services. The contract addresses tree maintenance pruning and removals on public properties and right of ways, including citizen's 311 action center request. This contract also required the contractor to provide storm response services in the amount of \$300,000.00

Amendment #2 will provide for tree maintenance services: tree maintenance pruning and removals on public properties and right of ways, including citizen's 311 action center requests at the same rates in the Parks South Region amount of 500,000.00, bringing the total contract amount to \$824,070.00. It is estimated that this contract will address approximately 1,500 trees in this Park Region. Funding in the amount of \$500,000.00 is available in account #3090-707771. On a motion by Commissioner Mecklenburg, duly seconded the Board approved Amendment #1 with Safety Tree Service Company to add \$200,000.00, extended the contract time to May 3, 2018 and authorized the Director or his designee to execute the amendment on behalf of the Board.

Background: The Board entered into an agreement with Safety Tree Service LLC on May 3, 2016 to provide tree maintenance Services. The contract addresses tree maintenance pruning and removals on public properties and right of ways, including citizen's 311 action center request. This contract also required the contractor to provide storm response services in the amount of \$300,000.00

Amendment #1 will provide for tree maintenance services: tree pruning and removals on public properties and right of ways, including citizen's 311 action center request at the same rates in the Parks North Region amount of 200,000.00, bringing the total contract amount to \$500,000.00. Dear Mr. Allen.

This regards proposed impacts to the Blue River Trail at the Blue River and 103rd St, as a result of the roadway and bridge reconstruction taking place for I-435 South Improvements - at the Blue River Trail Crossing.

We reviewed the options of mitigating trail use during the construction of the project. We are requesting a combination of option A and B. During construction keep trail open with protection under bridge and provide detour route signed and striped along 103rd St. When bridge construction is complete, pavement markings, traffic control devices, protected cover and signage will be removed and the trail will be restored to conditions that are equal to or better than pre-construction conditions.

Under Section 4(f) of the U.S. Department of Transportation Act of 1966, the Blue River Greenway and trail are considered a Section 4(f) resource. The Parks and Recreation Department, on behalf of the Board of Parks and Recreation Commissioners, as the official with jurisdiction over the Blue River Trail, I concur that impacts to this property are De minimis in that the proposed construction and completed project will not adversely impact the activities, features, and attributes of the resource that qualify it for protection under Section 4(f). The proposed construction area of the I-435 Improvements is anticipated to take place entirely within existing highway right of way, with no acquisition of Section 4(f) property.

During the first two planting seasons of this agreement HTA will have done the following: 1) planted 500 street and park trees in twelve different neighborhoods 2) planted 60 trees in three different parks to serve as educational arboretums 3) worked with Boy Scouts of America to create a program for a forestry badge which includes training and the planting of over 3,000 riparian trees. Amendment #1 extends the term of the agreement from May 31, 2018 to June 30, 2019 and increases the amount by \$300,000 for a total of \$600,000. In addition to continuing the neighborhood planting projects and work with the Boy Scouts, this amendment will include the following:

- 1. Restoration plantings in areas where honeysuckle has been

- 3. Create and implement an ash replacement program as either a "free tree give-away" or "rebate" program for homeowners

Background

In June 2016 International Architects Atelier (IAA) hired Gallagher & Associates to work with the project team and Museum staff to produce a Visitor Experience Plan for the Kansas City Museum historic restoration and renovation project. The new Visitor Experience Plan expands upon the 2010 interpretive plan, bringing it into alignment with the current architectural design plan, and preparing a solid foundation for future design and development of exhibitions and programs. Gallagher & Associates is an internationally recognized Museum Planning and Design Firm with offices in Washington D.C., New York, San Francisco, and Singapore.

The Visitor Experience Plan was completed on April 21, 2017, and it outlines six core interpretive and thematic stories, which will be explored throughout Corinthian Hall (the mansion) and the Carriage House in exhibitions, programs, events, and amenities. The Visitor Experience Plan sets the scope and parameters for exhibit design and development, which will be forthcoming. The six core stories are as follows:

Cultural Confluences: Rivers to 1880s

A City Beautiful on the Missouri: 1890s to 1930s

• Thriving Populations: 1890s to 1950s

WHEREAS, The Visitor Experience Plan sets the scope and parameters for exhibit design and development, which will be forthcoming;

Design Professional Services Agreement for Phase Three, Amendment #1 with

International Architects Atelier

Background

On August 23, 2016, the Parks Board approved a new design professional services agreement with International Architects Atelier (IAA) for Phase Three of the Kansas City Museum's historic restoration and renovation project. The scope of services includes design development and construction documents for Stage I Construction of Corinthian Hall including the lower level, first, and second floors. The agreement amount for Phase Three was \$928,828.00 through December 2019 and includes design development, construction documents, and bidding documents for Stage I Construction. The MBE/WBE goals set by HRD were 11.5% and 11.1% respectively.

Amendment #1 for Phase Three includes an additional scope of services and fee for design development and construction documents to add the third floor of Corinthian Hall to Stage I Construction. The total amount for Amendment #1 for Phase Three is \$189,000 through December 2019 and includes design development, construction documents, and bidding documents for the third floor; continued professional communications and community outreach services provided by Red Quill Communications; and continued program and design planning from the project artists and Gallagher & Associates. There is no change to the MBE/WBE goals set by HRD; they remain at 11.5% and 11.1% respectively.

Recommendation

Staff recommends Board approval of Amendment #1 for Phase Three for an agreement with International Architects Atelier in the amount of \$189,000 and requests Board authorization for the Director or designee to execute the agreement on behalf of the Board.

Background

The Parks Department issued an Invitation to Bid on October 3, 2016 for Construction Manager at Risk Services (CM@R) for Stage I Construction of the Kansas City Museum historic restoration and renovation project. Per the Invitation to Bid, the CM@R contract will extend through December 2019 and will be awarded in a series of Phases to include Pre-Construction Services and Construction Services.

Phase I of the Pre-Construction Services for a total amount of \$100,000 was approved on December 20, 2017 and has been completed. Work included the following scope of services: a detailed review of the design development documents and a detailed estimate based on these documents; review of documents for constructability and quality of all building components; cost alternatives to maximize value allowing as much scope as possible; development of a milestone schedule for design; first round of estimates and bid packages (including identifying early packages); and commencement of the development of the construction schedule.

This Amendment #1 for Phase II of Pre-Construction Services and is a total amount of \$185,000 through the end of May 2017. Phase II will include but may not be limited to the following scope of services: providing a detailed estimate of the 75% (or agreed-upon level of completion) construction documents; providing continuous pricing for options that the project team discusses, as well as cost alternatives for the project team to review; finalizing bid packages, as well as the construction schedule; and providing all other required items up until the bidding of the first bid package.

There are no HRD requirements for Pre-Construction Services.

Recommendation

Staff recommends Board approval of Amendment #1 in the amount of \$185,000 with J.E. Dunn Construction Co. to begin Phase II of Pre-Construction Services and requests Board approval for the Director or designee to execute the amendment on behalf of the Board.

Background

Ten bids were received and opened on March 8, 2017 for the Brush Creek Confluence Trail. The lowest and best-qualified bid received was from Gunter Construction in the amount of \$1,019,470.00. The base bid includes the installation of 3,138 linear feet of trail including a pedestrian bridge over the Brush Creek and a protective cover of the trail under the Union Pacific Railroad Bridge. This trail project will connect Brush Creek Trail, Cleaver II Trail, and the Blue River Trail.

This Federal/State funded project requires that the MBE and WBE goals for this project be combined into one DBE goal amount equal to 5% of the construction costs. Gunter Construction has received the State's approval as a general contractor, has met the State's DBE requirements. We have received bid award concurrence from the Missouri Department of Transportation. Work shall be completed within 300 calendar days from the date of "Notice to Proceed".

Funds for this Brush Creek Confluence Trail Improvements Project are available in accounts 3090-708309, 3090-708093, 3090-708509 and Developer Allotment Accounts.

Recommendations

Staff recommends Board approval for awarding the project base bid to Gunter Construction for a total contract price of \$1,019,470.00, with a total contract completion time of 300 calendar days, and requests authorization for the Director or his designee to execute the contract on behalf of the Board.

On November 8, 2016 the Board approved the Trailside Center Parking Lot Expansion Project in the amount of \$347,046.20. The project is located across the street from the Trailside Center and is intended to serve as ancillary parking with 31 additional parking spaces for the facility and as a trail head for the nearby Indian Creek Trail. The work to be done includes demolition of the existing asphalt and concrete parking lot and installation of a concrete and asphalt parking facility with lighting and landscaping.
